Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Taffs Well & Nantgarw Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

In my opinion, the Accounting Statement does not fairly present the Council's income and expenditure financial position:

• The Council has recognised a creditor, suggesting that the Council prepares its accounts on an income and expenditure basis. However, the Council has also recognised VAT income. If the accounts are prepared on an income and expenditure basis, the accounts must be prepared net of VAT.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

• The internal auditor answered 'No' to questions one and two on the internal audit report. The Council must ensure it addresses its issues to receive a 'Yes' response to these questions in the future.

Other matters and recommendations

There are no further matters I wish to draw to the Council's attention.
