Information provided by One Voice Wales:

"For councils reporting on a Receipts and Payments basis, figures on the annual return will be gross and councils reporting on an income and expenditure basis figures in the annual return will be net of VAT. "

As a Council with annual gross receipts & payments of less than £200k TWNCC is able to choose the accounting basis upon which its accounts are prepared.

It is recommended that the Council adopts a Receipts & Payments basis from the 1st April 2024.
