Representatives of Crocels Research CIC attended the May meeting of Council and :

(a) Asked what is the council going to do to ensure the Employment Hub in Nantgarw receives the same funding as is provided to the Community Hub

(b) Commented on the previous grant application and explained :
The advertised event charges are not used for residents of Nantgarw .
Services are provided to the community , including support to claim food vouchers & other benefits

The representatives sought a response to the above points at the meeting & as there was no Chair in attendance the Clerk adjourned the discussion .

The Clerk has apologised for the adjournment & invited the representatives to attend the June meeting .

In view of the adjournment it is recommended that council :

Agrees who will chair the meeting if Cllr's Bonetto, Edmunds & Probert decide not to participate in this discussion

Invite Crocels to make any further representations they consider appropriate

Considers the following 2 issues .

(a) Funding of the Community Hub

The Community Hub is the base for the community council & its funding status is therefore very different to other locations within our communities .

(b) Previous Grant Application

	<p>At the April meeting of Council the further information received from Crocels Research CIC (e-mail of 5th March) was discussed & it was recognised that the charges made are not nominal sums .</p> <p>The need to generate sufficient income to run the CIC was recognised & the community council decided that it would be inappropriate to award a grant .</p>
