#### 6. Member Reports

Cllr Edwards – Installation of water meters has created significant disruption & environmental damage

Cllr Lamford – Moy Road Pre-application consultation It was agreed that the response should highlight concerns with:

- Overdevelopment of the site
- Access arrangements & the detrimental impact on adjoining properties
- GP services inability to cope with the existing population
- Highway infrastructure inability to cope with existing traffic flows
- Adjoining properties being overlooked
- Loss of green space in a heavily developed area
- The close proximity of an industrial estate which is likely to lead to a detrimental impact on businesses & unanticipated problems for residential occupiers unfamiliar with the locality

( Cllr Bonetto took no part in the Moy Road discussion )
