11. Shared Charter between RCT & its Town and Community Councils for Adoption (Cllr Bonetto did not participate in the discussion)

Rhondda Cynon Taf County Borough Council and it's Town and Community Councils have agreed to publish a Charter which sets out how we collectively aim to work together for the benefit of local communities whilst recognising our respective responsibilities as autonomous, democratically elected statutory bodies.

The Charter is designed to build on existing good practice and embrace the shared principles of openness, to achieve the best possible outcomes for our residents and communities.
