<p>1.</p>	<p>Questions to the Community Council</p> <p>Suggestion from Resident (e-mail of 31st March) :</p> <p>I'd like to propose that council do the following with CIL funding:</p> <ul style="list-style-type: none">- extend the Taff Trail from the Parc Nantgarw roundabout along Oxford Street and up to the entrance of Albion House.- install an accessible fawn crossing, like on Cardiff Road, connecting the new pavement to the build out the opposite side of Oxford Street where the new Premier shop is located. <p>There is already a public right of way that could be moved to form the pavement and the crossing would make it safer for people crossing from the extended Taff Trail and Albion House to the new shop.</p> <p>It was agreed that the resident be thanked for the suggestion & RCT be asked to consider the above suggestion .</p>
